EQUIPMENT RENTAL (OAKDALE 2123)

PART 1 GENERAL

1.01 SUMMARY

- A. Section includes furnishing labor and/or specific equipment with operators as required for the proposed construction.
- B. Method of Measurement:
 - 1. Equipment:
 - a. Measure by time in hours.
 - b. Measure only actual working time and travel time within the project limits.
 - c. Street sweeper time will be measured only for time as directed by the Engineer for dust control purposes. General site maintenance and cleanup will not be measured.
 - 2. Labor:
 - a. Measure by time in hours for each laborer.
 - b. Measure only actual working time and travel time within the project limits.
- C. Basis of Payment:
 - 1. Contract price for equipment includes:
 - a. Operator
 - b. Tractive equipment as required
 - c. Accessories as specified
 - 2. Contract price for labor includes:
 - a. Hand tools as required
 - b. Contractor supervision
 - 3. Payment for labor and equipment shall be at the Contract unit price as listed on the Bid Form. All associated work items shall be considered incidental.

1.03 PERFORMANCE REQUIREMENTS

- A. All equipment and accessories shall be fully operational and in good mechanical condition.
- B. All equipment operated on bituminous or concrete surfaces shall be equipped with rubber tires or smooth street plates.
- C. Tractive equipment shall be rated and have sufficient power to effectively operate the drawn equipment.

D. Operators shall be fully proficient in the operation of the specified equipment.

PART 2 PRODUCTS

2.01 EQUIPMENT

- A. Comply with MnDOT 2123
- B. Provide the following equipment which meets the specific requirements and includes the accessories listed:
 - 1. Street Sweeper:
 - a. Pick-up broom type.
 - b. Minimum box capacity of 1.5 cubic meters.
 - 2. Motor Grader:
 - a. Self-propelled type
 - b. Pneumatic-tired wheels
 - c. Power-operated controls
 - d. Minimum weight – 19,000 pounds
 - e. Moldboard;
 - 1) Minimum 12 feet long
 - 2) Suitable cutting edge
 - 3) Scarifier
 - 3. Backhoe:
 - a. Full-revolving crawler type
 - b. Bucket size – 3 C.Y.
 - c. Bucket size shall not exceed manufacturer's recommendation for the shovel
 - 4. Front End Loader:
 - a. Power-operated loader
 - b. Minimum bucket size (struck) – 3 CY
 - c. Minimum excavation depth – 10 inches below tires
 - d. Capable of loading material into truck boxes
